PRESIDENT'S REPORT 2024

The International Gathering in Inverness was the main event of 2024. A huge vote of thanks was due to the UK Branch for their efforts to ensure the success of the gathering, and grateful thanks to David Holmes for chairing the 73rd AGM on 12th July 2024. I don't propose to repeat too much in this report as many accounts of the Gathering have been recorded in the inaugural edition of a combination 4 branch newsletters, I should say perhaps a four and a half branch newsletter, as the Chism Family Association (CFA) is a Chapter of the US Branch of Clan Chisholm Society.

This combination newsletter was itself a product of the 2024 International Gathering whereby representatives for the Australia, New Zealand, Canada, and US Branches thought that through the sharing of news and information, the social bonds between the branch members will grow; and importantly the workload required to produce the newsletter can be shared more widely. Time will tell if this turns out to be a successful experiment, it will require a conscious effort on the part of all the branches. A temporary name of the newsletter was trialled, the "Colonial Newsletter", seeking something which can tie the four branches together, and the constituent branch countries had all been colonies of the United Kingdom at some stage during the period of Chisholm migrations. The editors are open to any other name suggestions which members may feel more appropriate.

Another product of the 2024 International Gathering was the germ of an idea which Fay Chisholm presented to the Clan Council at the March 2025 meeting. This was to extend the artefacts project whereby photographic and fine art portraits of historical Chisholm personages could be gathered together in a digital format. The idea was approved in principle by the Council, with a subcommittee tasked with addressing the various issues of privacy, access, and copyright which may arise. It anticipated that this subcommittee can work through 2025 and report back to Council with recommendations.

A project from the previous year, digitisation of Clan Chisholm Journals up to the year 2001, was completed, though no decision on wider access has been made. This should be a task for the Clan Council during the 2025 year. In the meantime, digitisation of Journals from 2002 to 2017 will continue, but without a fixed timeframe for completion.

I thank the various Project Leaders for their continued work through 2024, and look forward to reading their reports, and thanks also to executive and Branch Officers for their dedication. We all know too well that this is voluntary work, and the more volunteers available the lighter the load will be.

As always, retention of membership remains an issue, and I hope that the council and the various branches can make some progress in arresting any decline. One of the great ironies of the digital age is that the easier access to media and information does not translate into membership of those groups which do a large amount of providing and safeguarding that information. The recruitment of millennials (b 1981-1996) into Clan Chisholm Society is going to become more imperative as time passes.

It has been a quiet year for us, but one with a sense of order, with Alun Chisholm as Secretary and Fay Chisholm as Treasurer.

Due partly to Alun's earlier health issues, it was convenient to have our annual general meeting relatively late in the year, on Saturday 16 November, by Zoom, which he organized, and we had quite a good attendance. An imaginary haggis was duly addressed and celebrated. Incidentally, later that same day, a large hikoi, a "march" involving several hundred people, mainly Māori, arrived in Palmerston North, in The Square, to stay the night in the city, before proceeding to Wellington to protest against a proposed government measure affecting Māori rights.

Sadly, during the past year, a couple of members have died, and others have become unwell, or more debilitated. Our first branch historian and genealogist, Audrey Barney, is in her nineties (born in 1927) and in a care home. My current project is to get printed in hard copy her latest book, on "Blind Jim" Chisholm of Houhora, which already exists as an e-book. James (1877-1954), originally from Melrose, Roxburghshire, came to New Zealand in 1903, and worked in Northland as a gum digger and then as an orchardist. Although he was already 38 in 1915, he volunteered to serve in the New Zealand army, in the First World War, and when his brigade went into action during the Battle of the Somme, he was badly wounded by shrapnel and permanently blinded. Back home, eventually, he was able to manage his orchard, with the help of his sister, and wrote quite a number of poems.

We seriously need to boost our branch membership, by inducing current members to enrol familymembers or friends.



MEMBERSHIP REPORT - compiled 5th March 2025



Membership of the Society in 2024 continued to fall in all branches except USA.

CLAN CHISHOLM JOURNAL

In 2024 500 copies were printed at 56 pages plus quality cover of 4 pages at a cost of £1,540, with no increase on 2023 cost. Distribution to branches came to £575.55 (2023 £611.05). The price per copy is currently set at £3.50 and intended to cover all costs. *Susan Chisholm – Hon Secretary*.

Thank you for the continuing trend of positive feedback on the 2024 Journal, #67, my eighth as editor. The balance of articles was a little heavy on the USA, which partly redresses the balance from previous years, but also is indicative of the direction the research takes me once I start a thread. Overall, the size and broad balance of articles for the global readership has been maintained covering individuals, companies, countries and items of general interest to all.

As always, I give priority to submissions from members, which allows me to edit and potentially expand, rather than research and create from scratch. I really do encourage both articles and ideas from members. Australia and Canada were underrepresented this year, so I will look to amend that next year, if possible, with member help.

I am very conscious that a significant proportion of the membership fees goes towards the production and distribution of the Journal. Current feedback is that it is an interesting read as well as a communication tool, so I plan to continue with my sometimes-random thoughts for content unless guided otherwise.


The website continued to receive scam messages particularly after the Gathering.

GENEALOGY REPORT

Forum - (https://www.chisholmgenealogy.com/cgi-bin/yabb2/YaBB.pl);

It has been a relatively quiet year on the genealogy front., The Forum and The Database being the interfaces provided by the Society, both of these theatres being the brainchild of the late Bob Chisholm, thank you Bob for your foresight and effort in setting these up/

The Forum Introductory thread has had just four visitations over the past year; these concerned Chisholms from New Hampshire, Aberdeen, and Chisms from Missouri. There was also a thread of 21 posts initiated by a correspondent (Graham Browne) from South Africa, concerning Donald Malcolm Chisholm, OBE. Graham was trying to locate descendants, so that medals, including the OBE, and other treasures could be returned. The Medlam charts for India (SmL1 Page 02) were very helpful in the quest.

The Genealogy Board had activity over 2 threads. One involved an item sent by my cousin in Inverness, concerning the family of Pipe Major Malcolm Chisholm. Members of this family were contributors to Clan Chisholm Society in its earlier years. A thread a Chisholm family from Skye, initiated 4 years ago, received some updates. Perhaps the biggest buzz on the genealogy front during the year has been concerning the connection, or lack thereof, of the Teawig Family to the Thomas Chisolm of Georgia Family. This thread was initiated over 12 years ago, as Bob Chisholm had uncovered a document which cast light on a family history story which had been growing in the US since the 1980's. In part, the propagation of this family history was aided via an article by Wilf Medlam in a Clan Chisholm Journal. Resolution was achieved some time ago, but general publication was withheld so that it could be released via an article in the Clan Chisholm Journal. The chief researcher, (Sherrie Cork) a descendant of Thomas Chisolm of Georgia, and a forum member, conducted much of the research behind the scenes, off forum, but still maintained contact. She sought to prove once and for all that Lieutenant Thomas Chisolm of Georgia was Thomas Junior, son of Rev Thomas Chisholm of Kilmorack (known as Teawig Family). Ultimately she proved Bob's contention, that the Teawig and Georgia families were unrelated. She did scour all the Highland Articles, but found the answer which eluded so many Clan Chisholm Society sleuths, hiding in absolutely plain sight. Thomas the younger of Kilmorack was just a mile or two down the road from the Kilmorack Church. Sue Thomson and the KHA knew all along but no doubt never knew we were looking. He was found in the KHA booklet on Teanassie. As far as the database is concerned, when new information is found, it is sent to the DB administrator for updating. This is the case for the Teawig Tree, and any other for which information comes to light either in Forum activity, or elsewhere. A future project for the Database has been mooted, the integration of the Family Trees held in the Australia Branch Database. This sounds like a great idea, as the Australian database is comprehensive, but its looking like software incompatibility makes simple transition either not possible or very difficult.

CHISHOLM HISTORICAL RESEARCH / (Chisholm Chronicles Project)

Border Chisholmes Research:

During the International Clan Chisholm gathering in Inverness in July 2024 Dr Margaret Collin gave a lecture on her recent research into Border Chisholm History. Margaret has uncovered material not examined previously and was able to share it with those in the room. The talk was fascinating and showed the immense amount of research that Margaret has been doing over the past few years. Questions on the research followed which provoked good discussion within the room. Margaret is hoping to bring the research together into a book for the Society. Before that can be completed, she must obtain rights to use various documents and images, that is why she was unable to share her presentation with us and asked that we did not take photographs of it. *Susan Chisholm August 2024*

The historical research into the Borders Chisholmes has now progressed a long way as, I hope, I demonstrated at the International Gathering in Inverness last summer.

Many of the original documents, although not impossible to trace, were not all held together, but were scattered into various collections or into the hands of private individuals. Well, needless to say, more documents have turned up and my search continues!

For a long time I have been pursuing the documents left by the Chisholme families who lived in The Stirches at Hawick - and at long last I have found some information on where they may, or at least some of them, may be located. I have still to investigate this possible new source - but I shall keep you posted on progress.

ARTEFACTS REGISTER

Progress has been slower in 2024 due to other commitments.

At present there are 41 artifacts registered.

Some discussion has begun on an idea which arose at the International Gathering on extending the project to include photographic information on artefacts of Chisholm interest not held by Society members. There are a number of concerns already raised regarding this potential project.



DNA PROJECT REPORT

Total membership of the project stands at 448 (as of 17 March 2025) and the graph shows the same slow but steady growth since 2020.

Of the 448 total, 72% have been in the Y chromosome side of the project, with 252 members having taken the all-important Y67 test, while 134 of these have extended to the Y111 test.

Membership of the Family Finder test continues to grow; this type of test covers the wider family rather than the specific Chisholm family which is targeted by the Y chromosome test.



One of the results to note was that Chism named tester matched to the Chisum/Chisholm named members descended from John Chisum/Ellender Gillentine of Amelia Co. Virginia. This is a family group whose Chisholm origin is still shrouded in mystery, and the Y-DNA clues point to a distinct possibility of a maternal descent.

Other results in the Y chromosome project tended to consolidate existing known groupings.

The project has been in existing for 19 years, and has many years ago completed one of the primary goals, which was to provide a scientific basis for the Norman origin of the Chisholm founder. Another main task was to categorise the various separate family groupings which made up the Highland Clan. It is proposed that on the 20th anniversary of the project, a thorough review of the findings should be made.

Chair of the meeting David Holmes said a few words of greeting and invited Kim Polley to read out an address from Robert Chisholm, New Zealand, President of the Clan Chisholm Society. This is shown in full below:-

Greetings to all of the Clan assembled for the 9th International Gathering.

Clan Chisholm Society International has come together in 1985, 1989, 1993, 1996, 2001, 2003, 2008, 2011, and 2014. These have all taken place in the Scottish Highlands and Chisholm Heartlands, with the exceptions of 2003 (Antigonish, Nova Scotia, Canada), 2008 (Canmore, Canada), and 2011 (Duluth, USA). It was not meant to be a 10 year interval since the last gathering; however the Covid situation meant that an earlier date could not be planned.

And so, it's appropriate that Chisholm Colonial Tartan comes from a descendant of this family, designed by Kat Moore in conjunction with Duncan Chisholm, and approved by Chief Hamish at the 2008 gathering.

David, I am very confident and happy that you will be at the gathering to fulfil the Presidential role, a VP from a family which has given such long and valued service to Clan Chisholm Society.

Kim, Tony, and the rest of the Australians, the senior colonial branch of the Society, while I am sad at not being able to meet up with you this time, you are just across the ditch so I won't be ruling out another trip or two to the West Island.

My Gr Gr Gr Grandfather was cleared from here in 1801, and I assume he was one of the fortunate souls saved by Lord Lovat.

Aigas, now a Golf Course, formerly a sawmill, part of the former Lovat Estate. Here my great great grandfather was born.

Eskadale Church where my Gr gr grandparents were married in 1828, and the resting place of so many Chisholm's.

Breakachy, above Aigas and Erchless, an ancient Chisholm estate, where my Great Grandfather was born, from where he left in 1869 aged 19, and made his way to New Zealand by 1871, where eventually he built a fine farmhouse and named it "Beauly".

Discussion:

Juliette Chisholm-Broomfield informed the room that Dr Jean Munro was now 100 years old and held an honorary position only, she remained mentally very active. Dr Margaret Collin and others in the Society now manage historical enquiries and research.

He noted that the WW1 project was not now listed as a separate project under Robert Chisholm, New Zealand as it is more or less complete and just running along with a few additions and amends as they arise, and when new information comes to light. David noted that Clan Council had not had any further offers to take on duties.

Appointments are approved by Clan Council – a show of hands in the room supported the list.

AGENDA ITEM 6 – NEW BUSINESS

6a. Branch Newsletters - Joint approach

Kim Polley informed the meeting that the New Zealand and Australia branches had produced a combined Newsletter twice per year for some time. This had been very successful and spreads the workload. The newsletters therefore involve half the effort and provide double the interest. She noted that the UK produces a newsletter four times each year to its members and is very active. Other branches particularly US and Canada have struggled to get help to produce a branch newsletter. It is suggested that the four branches; Australia, New Zealand, Canada and US contribute to a joint newsletter. Kim helps with the Chisholm DNA research. Members might like to read some articles about DNA in their newsletters. Articles can be social with personal articles from members and not just academic. It can be fun. Kim suggested the branches buddy up and the newsletter can be emailed to members of those four branches. She asked if members thought this would be of benefit. It was thought that it could encourage and capture younger members and keep their interest. Perhaps each branch would have 3 to 4 pages. Susan noted that the regular newsletters were a good way of keeping in touch. It was also suggested that some of the UK newsletters articles could be shared. The joint newsletter could be more interactive and include questions especially in respect of DNA and genealogy. David and Susan agreed that regular contact with the membership also helps us know when someone has passed away rather than just decided not to renew membership.

Joyel thought the joint proposal sounded a lot more manageable especially in those branches which have fewer members putting themselves forward for empty positions on branch committees.

Fergus Atkinson-O'Sullivan suggested that more people accept electronic newsletters. Perhaps a website could have an electronic subscription button to access newsletters. There must be thousands of Chisholm's out there. Kim agreed that new technology is the way to penetrate the 'market place'. Tony Morrison knew of a person who had found us on line and joined up. Fergus suggested a subscription link on current website and Clan Council members present agreed to look into this. David pointed out this was an embryonic idea at present which would need to be discussed with branches but he added that members should 'stay tuned'.

Margaret Collin suggested a balance of social and more serious articles but cautioned against infringement of copyright. Margaret had written an article for UK which had been picked up by someone working on a project. Folk can just pick up anything on line and use it.

Tony Morrison added that young people operate on social media, Facebook etc just putting up an item guarantees a reaction from other younger folk.

Ben and Juliette Chisholm-Broomfield raised a question about security and unwanted attention which would need to be guarded against.

6b. 2024 Gathering.

Susan noted again that if all agreed she would list the email addresses of all those who have attended the gathering week and distribute amongst us. She reminded members that their joining packs contained a QR code to use to upload their photographs of the week so that we could all enjoy viewing them.

Fay Chisholm then made a presentation of gifts from New Zealand to both Susan and Juliette with thanks for the hours put in to organising the gathering. She also thanked Danu for her hard work and great support over the week.
